



STATEMENT

I hereby declare I have read the current regulations of SKW Racing Park in Skawina and I undertake to strictly apply to its provisions, which I confirm with hand signature placed under the contents of the statement.

In particular, I declare that:

1. I meet the criteria of having appropriate physical conditions required by SKW Racing Park regulations. In relation to minor participants that remain under my care, this means they are of minimum age of 4 and are at least 110 cm high or are 8 years and are at least 120 cm tall; they can use the racetrack only with my consent and in my presence.
2. I and my charge do not have any health contradictions that prevent from using the racetrack safely, in particular no heart, neck or back diseases, neurological diseases manifesting loss of consciousness or epilepsy, or musculoskeletal system disease. I declare I am not pregnant. I declare I have consulted the doctor regarding any doubts in this respect before entering the racetrack.
3. I and my charge are not under the influence of alcohol, narcotics and psychotropic substances, including drugs and psychoactive substances, as well as medications and other means that may affect my behavior as a driver or as a passenger of this vehicle. It is forbidden to consume and use the abovementioned substances on the racetrack.
4. It is forbidden to bring sharp tools and other dangerous objects in the racing track zone.
5. I will leave the clothing, bags, backpacks and other items brought to the racing park in a locker. The Organizer is not responsible for theft, loss or destruction of the abovementioned items as well as the items left by me or my charge in the racing track zone without supervision.
6. I / my charge are not allowed to drive with loose clothing such as scarves, headscarves, loose blouses. It is forbidden to drive with long loose hair. I declare to bind them before entering the racing track.
7. I / my charge will keep our personal belongings, such as keys, coins, smartphones in a tightly closed pocket, in a locker or in the other safe place.
8. The racetrack is a route intended for go-kart, Pitbike / other two-wheeled vehicles designated by the Organizer. It is prohibited to remain off the racetrack and in other places that are dangerous to the user. Racing may only be clockwise and on a designated racetrack route. Before using the racetrack, I and my charge have participated in the training covering the use of a go-kart, Pitbike / other two-wheeled vehicles, organization of the racetrack and safety rules.
9. It is absolutely forbidden to get off the go-karts both while driving and when the vehicle is stopped due to a breakdown or interruption of the race by the Organizer. It is possible to get off the vehicle after stopping the go-kart at Pitstop and receiving permission from the racing park staff.
10. It is not allowed to chew gum or other substances while driving.
11. I and my charge will wear a protective helmet and appropriate protective clothing required for driving, as described in the SKW Racing Park Regulations.
12. I and my charge use the right footwear for driving (non-slippery, fully covering feet). It is forbidden to drive in flip flops, high-heeled shoes or other footwear not suited for driving.
13. I acknowledge and ensure that I and my charge are aware that there is a power unit in the rear part of the vehicle that reaches high temperature while driving, which can cause accidental burns or damage to outerwear.

14. On the racetrack, I and my charge undertake to strictly comply with the provisions of the SKW Racing Park Regulations, the safety rules while driving and the Organizer's orders and directions, traffic lights and signal flags. In particular, I acknowledge that my / my charge's responsibility is:

- to start racing after the appropriate signal,
- to comply with the Organizer's decision on the number of vehicles allowed on the racetrack, driving order, time interval between starters, break in racetrack operation, interruption of the race,
- to keep extreme caution on the racetrack,
- to immediately stop after signaling the end of race,
- to not drive in the opposite direction to the one designated by the Organizer,
- to not hit other vehicles or barriers, push other vehicles on the barriers,
- to keep the safe distance between other vehicles,
- to not drive in a manner that prevents other go-karts from passing by,
- to not drive the vehicle to make it swerve,
- to not destroy or deliberately damage the equipment.

I acknowledge that all Organizer's decisions are final and are not subject to discussion.

15. In the event of stopping the vehicle while driving for reasons beyond my control I and my charge declare to signal this by raising a right hand and remain in the vehicle until the racing park staff allows to.
16. In the event that I show lack of driving skills or I move on the racetrack too slowly that blocks other participants and pose a threat due to lack of control over the go-kart / Pitbike, the Organizer has the right to refuse further driving. I acknowledge that all Organizer decisions are final and are not subject to discussion.
17. When using my own Pitbike, I confirm its technical condition allowing for safe driving and equipping it with necessary accessories (so-called "quiet exhaust"). In the event of a Pitbike failure (braking system, excessive emissions, etc.) I will inform the staff immediately and end the ride. I acknowledge that all decisions of the Organizer regarding technical condition are final and are not subject to discussion.
18. In case of using a Pitbike provided by the Organizer, I agree to adapt my riding style to my skills. I will not lead to situations where the Pitbike could be damaged / destroyed due to a fall. I have been informed about the right to verify the technical condition of the Pitbike before the start of the ride and I undertake to return it after the end of the ride in unchanged condition. I undertake to cover all damages caused during and as a result of my riding on the basis of the pricing list on www.sklep.pitbikemrf.pl
19. I and my charge are obliged to inform the Organizer of any irregularities, failure or damage and behavior inconsistent with the SKW Racing Park Regulations and the rules of using the racetrack by other participants.
20. The Organizer is not responsible for the consequences of accidents resulting from my and / or my charge's failure to comply with the provisions of the SKW Racing Park Regulations, safety rules during the ride and the Organizer's instructions and orders, traffic lights and signal flags, including those causing damage to my health or my charge's health or property. I am aware of the consequences of non-compliance with the obligations described in this statement and use the racetrack at my own risk.
21. This statement applies every time when visiting SKW Racing Park.

GDPR INFORMATION CLAUSE

According to art. 13 section 1-2 of Regulation 2016/679 of the European Parliament and the European Council of 27th April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter referred to as "GDPR") we inform that:

1. The Administrator of your personal data is a company under the name Simple Collection s.c.,(partnership) address: Piekary 353, 32-060 Liszki, NIP: 9442253323, REGON No.: 365972826 (hereinafter referred to as „Administrator”).
2. By signing this statement you agree to the processing of your personal data for the purpose of keeping a register of SKW Racing Park users at Fieldorfa Nila street 7 in Skawina and to measure the time of racetrack users, display this measurement in public and print it. Providing data is voluntary, however, providing such data is a condition for your use of the services provided by the Administrator.
3. It is unacceptable for the Administrator to process your personal data for the purpose of direct marketing, except for situations where you have expressed, voluntary, specific, informed and unambiguous consent.
4. The Administrator is obliged to protect personal data in accordance with the GDPR. In order to ensure the security of personal data, the Administrator takes the necessary technical and organizational measures tailored to the degree of danger, excluding the possibility of obtaining and modifying this data by unauthorized persons.
5. The recipient of your personal data remains the Administrator. Your personal data may only be transferred to persons authorized by the Administrator, including employees of the Administrator who have been granted written authorization to process personal data, as well as to persons cooperating with the Administrator with whom personal data processing agreements have been concluded. These persons are responsible for violation of the processing rules.
6. Your personal data shall not be transferred to third countries.
7. Your personal data shall be stored as long as it is necessary for the provision of services by SKW Racing Park, and in addition to the extent necessary until the expiry of the limitation period for claims due to you against the Administrator or due to the Administrator against you.
8. You have the right to object to the processing of your personal data at any time, processed for the purposes and on the basis of the principles indicated above. We shall stop processing your personal data, unless we can prove that there are valid, legally justified grounds that override your interests, rights and freedoms or your personal data will be necessary for us to determine, assert or defend claims.
9. You have the right to request the Administrator to access your personal data, rectify it, delete or limit processing, as well as to lodge a complaint to the President of the Personal Data Protection Office.
10. You may receive from the Administrator in writing or in the form of a Word file access to your personal data collected and processed by the Administrator at any time, as well as send this data to another entity chosen by you without any obstacles on the part of the Administrator.
11. The Administrator does not profile or make decisions on your behalf in an automated manner.
